1. Information We Collect

We collect information in the following ways:

- Directly from you: When you sign up for newsletters, register, or make a donation, we
 may collect your name, email, address, phone number, and payment details (processed
 securely by Zeffy).
- Automatically: Through cookies and similar technologies, we may collect your IP address, device type, browser, pages visited, and interaction data. This information helps us improve the Site and understand visitor behavior.
- From third parties: If you engage with us through social media or linked platforms, those services may share information with us according to their own policies.

2. Cookies and Tracking

We and our hosting provider, Wix, use cookies and analytics tools to improve Site performance and personalize user experience. You can disable cookies in your browser, but some Site features may not function properly.

3. How We Use Your Information

We use information to:

- Provide and improve our Services.
- Process donations and communicate with donors.

- Send newsletters, updates, and fundraising appeals.
- Respond to inquiries and requests.
- Monitor Site usage and trends.
- Comply with legal obligations.

4. Donor Privacy

We deeply value the trust of our donors. To support donations, we use Zeffy, which securely processes all payment information.

- Donor names, addresses, and contact details are collected only for donation processing, acknowledgments, and communications.
- Payment card details are handled solely by Zeffy in compliance with PCI DSS security standards. The United Arc does not store full credit card numbers.
- Donor information will not be sold, traded, or shared with other organizations.

5. How We Share Information

We may share information only as follows:

- With trusted vendors and service providers (e.g., Wix for hosting, Zeffy for donations, mailing firms for communications).
- To comply with legal obligations (court orders, subpoenas, law enforcement requests).
- As part of organizational changes (e.g., merger, asset transfer).
- To protect rights, safety, or security of The United Arc or others.

We do not sell or rent your personal information.

6. Security

We implement reasonable safeguards, including encryption, access controls, and monitoring, to protect your information. Despite these measures, no system is 100% secure, and we cannot guarantee absolute security.

Donation transactions are protected using industry-standard encryption and Zeffy's secure processing environment.
